

HOGS & LAMBS PRE-ENTRY FORM INFORMATION FOR 2018 SHOW
SPRING FAIR DATES: APRIL 18 – 22, 2018

1. HOGS MUST BE OWNED & HAVE IN YOUR POSSESSION ON OR BEFORE JANUARY 20, 2018, not born before September 25, and not weigh over 150 lbs. at the tagging in January.

LAMBS MUST BE OWNED & HAVE IN YOUR POSSESSION ON OR BEFORE FEBRUARY 20, 2018.

2. Pre-entry forms for hogs must be returned by December 18, 2017 (must be tagged by February 1).
Pre-entry forms for lambs must be returned by February 1, 2018 (must be tagged by March 1).
3. \$5 per head tag fee must be sent in with pre-entry form. Please make checks to Northwest Junior Livestock Show. Entries without payment will be returned.
4. YOU MAY PRE-TAG UP TO 4 HEAD OF LIVESTOCK (combined total of all livestock). Only 2-head will be allowed on Official Entry Form that will be in your Rules & Regulations book that will come out in February. ALL LIVESTOCK MUST BE PRE-ENTERED AND PRE-TAGGED TO ATTEND OUR SHOW. ONLY 2 HEAD CAN COME TO SCALE.
5. Please list tag numbers on official entry due March 18, 2018. Entrants cannot participate in 4-H and FFA.
6. Leaders and advisors will be provided tags and taggers by the NWJLS shortly.
7. Leaders and advisors will use the supplied tags to tag all hogs in their club/chapter and immediately return the tagger to the NWJLS UNLESS YOUR CLUB OR CHAPTER ALSO HAS LAMBS TO TAG. In that event, send back the tagger after tagging all lambs.
8. Leaders and advisors will certify that the hogs have been timely and properly tagged and return those signed certifications to the NWJLS by February 1, 2018.
9. The certification will be done on a form identical to the certification attached hereto.
10. All tagged hogs will be photographed at tagging as more fully set forth below.
11. Hog pictures will be emailed to NWJLS.tag@yahoo.com no later than February 1, 2018.

Please note that the pictures must show each hog with its tag(s) in place and with enough of the hog captured in that picture that it can be fully identified and matched to the photograph. Our goal with this part of the rule is to ensure that the hog tagged is the one exhibited at the show. Also, all hogs must show up at the fair with both tags intact; absent prior arrangements with the NWJLS.

The tagging rules set forth in this letter supersede any conflicting hog tagging rules in the NWJLS exhibitor book. All rules in the exhibitor book, on all pre-entry forms and on all other letters/documents the NWJLS has issued for the 2018 NWJLS event are still in full force and effect, with the exception of the rule changes set forth in this letter. Of course, failure to comply with any rules, including those set forth in this letter, will subject the exhibitor(s) who do not comply to the sanctions or penalties specified in the NWJLS rules/regulations.

If you have questions, comments, or concerns, please contact us. We welcome any suggestions you and the exhibitors may have as those suggestions allow us to make more fully informed decisions as a Board. Also, if you would like to have a NWJLS Board Member available at tagging, please let us know. We will try to accommodate you in that regard.

CERTIFICATION FOR TAGGED HOGS

The undersigned, who is a leader/advisor for hog exhibitors in the upcoming NWJLS event held at the Washington State Fair, hereby certifies that all hogs in my club/chapter were properly ear tagged in both ears on or before February 1, 2018, with the tags provided to me by the NWJLS and assigned to the hogs in my club/chapter. To the best of my knowledge and belief, the hogs that were tagged meet the age and weight requirements specified by the NWJLS rules and regulations as of the time of tagging. The tagged hogs were photographed after tagging such that the ear tags and the hogs can be sufficiently identified as specified by NWJLS rules pertaining to hog tagging. The photographs were then emailed to: nwjls.tag@yahoo.com. I have informed the exhibitors that the hogs must show up at the fair with both ear tags intact, absent notifying the NWJLS and having explained to the satisfaction of the NWJLS why or how one or both ear tags were removed or otherwise lost. If any hog shows up to the fair without both ear tags intact and without the exhibitor having made prior arrangements with the NWJLS, then the hog will be excluded from the event. I agree to return this signed and dated certification to the NWJLS within one week after the tagging deadline. Lambs must be pre-tagged by March 1, 2018.
